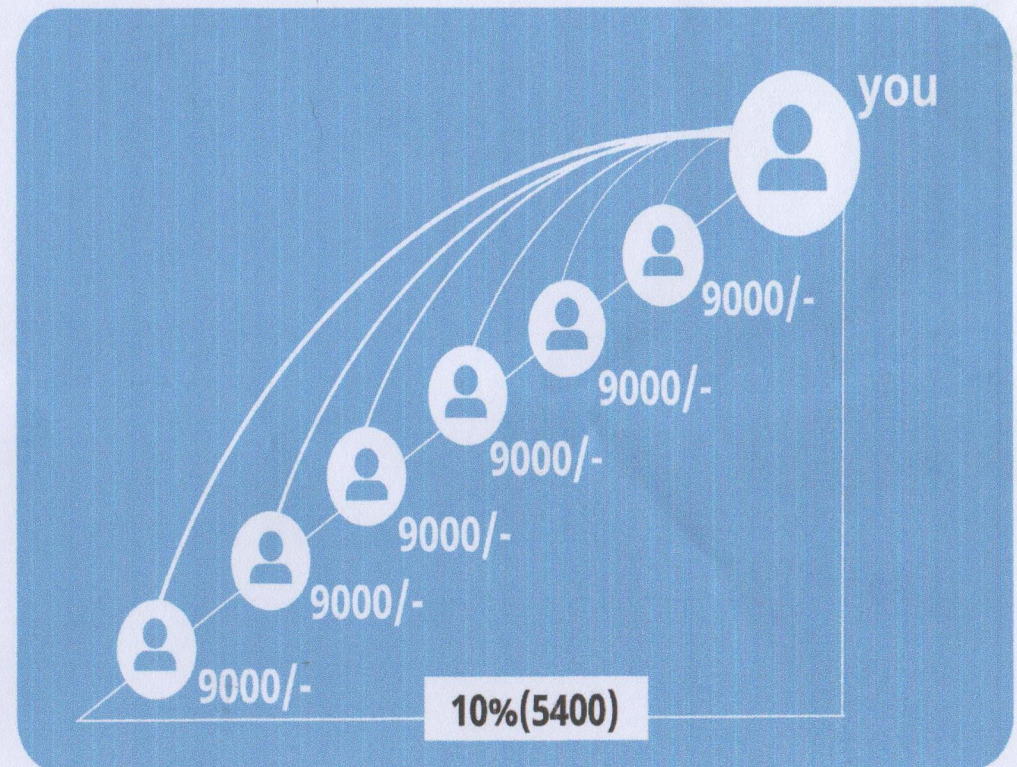
- First you have to activate your id in first purchase income plan.
- The moment you purchase Zivitas Products worth of Rs. ₹ 750 / ₹ 1500 / ₹ 3000 as per your choice, your id will be activated in First Purchase Income plan.

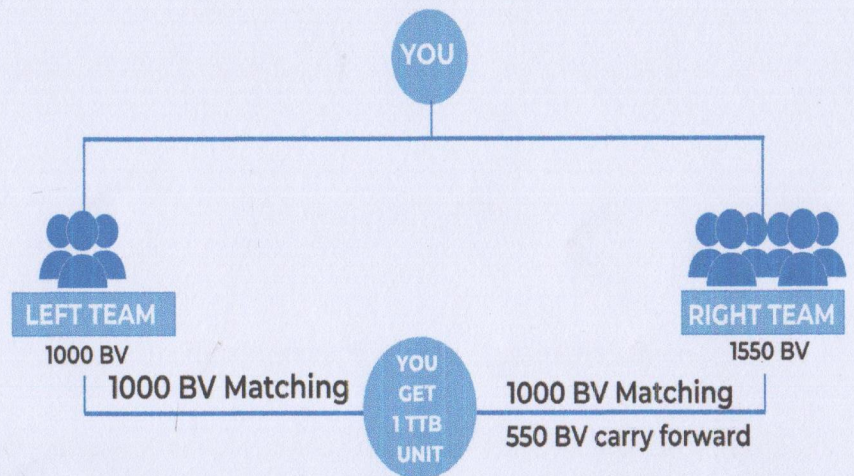

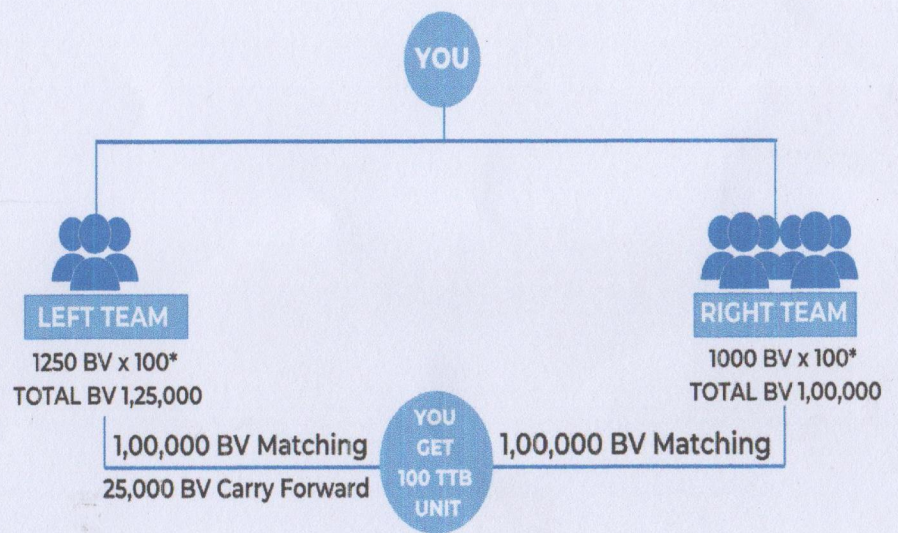

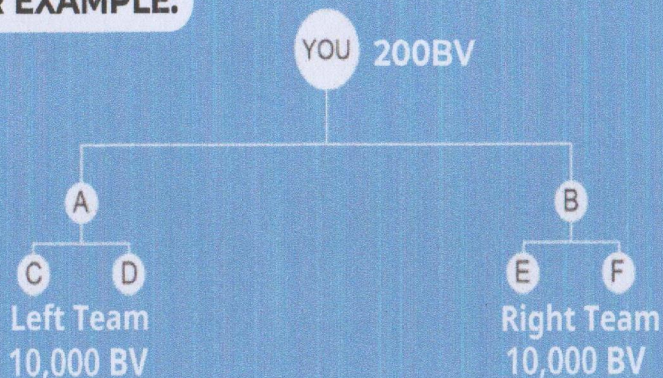


6. TEAM MENTORING FUND 5%

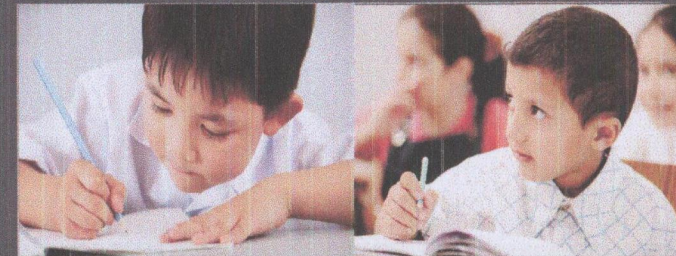
